Financial Protocol and Payment Options

Thank you for choosing us as a provider for your dental care. We are committed to providing quality services, and to the success of your treatment. Treatment options and findings will be discussed following your examination. We will also discuss with you the estimated cost of treatment.

PAYMENT IN FULL IS DUE ON THE DAY THE SERVICE IS PROVIDED unless special arrangements have been made prior to treatment. We are sensitive to the fact that some patients may not be able to pay cash for their treatment. Therefore, we offer alternative payment programs for your convenience. We accept cash, checks, American Express, Master Card, Visa and Discover. Care Credit™, a third party financing program, is also available for those approved through application.

INSURANCE: Patients covered under dental insurance must present their dental insurance card prior to treatment. As a service to our patients, we do submit your insurance claims for you. We are not accountable for your insurance company's preference of treatment, amount of payments or time of payments. At the date of service, payment for the estimated amount insurance will not pay/cover is due. All accounts will be charged interest after 60 days and are to be paid in full by the patient if insurance has not paid by that time.

EXTENDED PAYMENT ARRANGEMENTS: Although we do not offer any "in house" financing, we do offer a third party flexible finance program endorsed by the American Dental Association (ADA)- Care Credit™. This program is easy to apply for and is processed within our office. Approval results are known within minutes. If this seems like a desirable payment alternative, please ask our front desk personnel for more information.

MEDICAL ASSISTANCE: (MA, PRIME WEST & BLUE PLUS) We require that patients register their MA information with the office and provide eligibility before each appointment. Dr Kevin P Williamson & Dr. Jeffrey A. Hauger do not participate in the Ucare program. Ucare patients are required to pay in full the day of treatment. Please check in advance to verify whether or not Dr. Kevin P Williamson & Dr. Jeffrey A. Hauger are a participating provider in your Medical Assistance program.

PREFERRED PROVIDER PROGRAMS (PPO): If your dental insurance is considered to be a PPO, please check in advance to verify whether or not Dr Kevin P Williamson & Dr. Jeffrey A. Hauger are part of your PPO's provider network.

PAST DUE ACCOUNTS: Patients may have their treatment suspended if their account becomes delinquent. Only emergency treatment will be provided until the balance is paid in full. Should the account be referred to collections, the patient shall pay reasonable attorney's fees and collection expenses.

MISSED APPOINTMENTS: We require 24-hour notice for all cancelled appointments with the exception of illness, emergencies or weather related cancellations. If patients do not give us adequate notice, we reserve the right to request a **deposit of \$50** in order to schedule subsequent appointments. This deposit will be put toward your next bill if you make your next appointment, but will be lost if you fail your next appointment. Late patients affect many people and can result in rescheduling the appointment. Thank you in advance for your consideration.
